# YOUR CAREER GOALS, ACCELERATED

Nothing will quite prepare you to be a prosecutor like the hands-on training you will receive in the 14<sup>th</sup> Circuit Solicitor's Office externship program.

"Being a public servant, fighting for justice and the opportunity to argue in front of a jury are the reasons I want to be a prosecutor," said Michelle Hart, a Charleston School of Law student and a member of the 14<sup>th</sup> Circuit Solicitor's Office externship class of 2019. "But sometimes people get lost in the *Law and Order* aspects of prosecution. A lot goes on behind the scenes, and you won't learn it all in law school.

"This program has taught me things and given me vital skills that I could not have received elsewhere."

Students selected for the externship are fully integrated into the Solicitor's Office daily operations. They attend hearings, meet with law enforcement officers and witnesses, and prepare formal case analyses.



Hart, pictured above, also helped research a project on asset forfeiture, reconstruct a fatal automobile accident at the heart of a felony DUI case, and call the docket during a term of General Sessions Court.

"There is such an atmosphere of teamwork here," Hart said.

"Whether it's the attorneys, the investigators, the administrative staff – no one shies away from answering my questions. It's a great learning environment."

"The really great thing is that I felt like I was contributing," Hollen said. "I wasn't just there to spectate."

The experience not only confirmed Hollen's desire to be a career prosecutor, it helped him land his first job.

"I treated it like a 2 ½ -month job interview, which really is exactly what it was."



## What we do

The Fourteenth Circuit Solicitor's Office is the chief prosecuting agency for Allendale, Beaufort, Colleton, Hampton and Jasper counties in South Carolina's Lowcountry. Our headquarters are in Bluffton, S.C., just minutes from Hilton Head Island's beaches. We prosecute all cases in General Sessions and Family Court. We have about 50 employees, including seven victim advocates assigned to teams of attorneys.

During the 2019 fiscal year, we prosecuted more than 4,600 cases.
