Those recommendations in Green are Joint Recommendations and will be presented and updated by Solicitor Stone. It is important that this group check on the status of the recommendations and provide follow-up.

<u>Old Business</u>: Discussion ensued of a Victim Service model out of California and now replicated in Georgetown (Family Justice Center). The committee believes these are somewhat replicated in Spartanburg, Lexington, Greenville and Pickens. Are these one stop shops for DV? Transportation seems to be an issue. The presence of Law Enforcement may hinder victim services.

Sistercare has advocates in Richland and Lexington Counties.

<u>New Business</u>: NBC did a report on the young lady held captive in Spartanburg. Discussion ensued around privacy concerns and the FOIA law.
